Subject: Request to treat Post Graduate Diploma in Sports Coaching of Lakshmibai National Institute of Physical Education (Deemed University), Gwalior and Netaji Subhas National Institute of Sports (NSNIS), Patiala at par-reg.

Sir/Madam,

It has come to the notice of the of this Ministry that some of the State Governments and Universities while making recruitments or issuing advertisements for the post of coaches have not been considering the PG Diploma in Sports Coaching issued by the Lakshmibai National Institute of Physical Education, Gwalior at par or equivalent with that of Netaji Subhas National Institute of Sports (NSNIS), Patiala.

2. In this regard, instructions have already been issued by this Ministry vide its letter No. 19-2/2007/ID dated 27.12.2007 that the PG Diploma Courses in Sports Coaching conducted by the Lakshmibai National Institute of Physical Education, (LNIPE) Gwalior, a Deemed University and an autonomous body of this Ministry are on par with PG Diploma Courses in Sports Coaching offered by Netaji Subhas National Institute of Sports (NSNIS), Patiala which is an institute under Sports Authority of India which, in turn, is another autonomous body under this Ministry. Copy of the said letter is enclosed for ready reference.

3. It is further clarified that LNIPE, Gwalior is a premier Institute, and has been upgraded to the status of a Deemed University in 1995 whereas NSNIS Patiala is an Institute and which is affiliated to Punjabi University for purposes of award of diploma in sports coaching. As the institutions enjoy equality of status, it is discriminatory to the diploma holders of LNIPE, Gwalior to deprive them of the benefit of qualification besides causing avoidable hardship to them and thus needs to be avoided.

4. The whole matter has been considered at the highest level in this Ministry. After consideration it has been decided to once again issue strict instructions to all concerned to treat the PG diplomas of both the organizations/Institutes at par in all future recruitments and for all other purposes. This would help avoid inconvenience and discrimination to Diploma holders from LNIPE, Gwalior.

Sir/Madam,

I am directed to invite your attention to the subject cited above and to say that the PG Diploma courses in Sports Coaching conducted by the Lakshmbai National Institute of Physical Education(LNIPE), Gwalior, a deemed university which is also an autonomous body of this Ministry, are on par with PG Diploma courses in Sports Coaching offered by the Netaji Subhas National Institution of Sports, Patiala.


The LNIPE, Gwalior is a premier institute, which was established as a College in the year 1957 and has been upgraded to the status of a Deemed University in 1995.

It has come to the notice of this Ministry that some of the state governments and universities while making recruitments or issuing advertisements for the post of Coaches, have not been considering PG Diploma in coaching of LNIPE, Gwalior as equivalent to that of NSNIS, Patiala, which has created an anomalous situation.

In view of the clarification given, you are requested to issue appropriate instructions to all concerned to treat the PG diplomas of both the organizations at par in all future recruitments. A copy of such instructions issued may also kindly be endorsed to this Ministry.

उपरोक्त विषय पर मुझे यह कहने का निदेश हुआ है कि लक्ष्मीबाई राष्ट्रीय शारीरिक शिक्षा संस्थान, ग्वालियर जो कि एक समकक्ष विश्वविद्यालय है तथा इस मंत्रालय के अधीन एक स्वायत्तशासी निकाय भी है द्वारा संचालित खेल प्रशिक्षण में स्नातकोत्तर डिप्लोमा पाठ्यक्रम नेताजी सुभाष राष्ट्रीय खेल संस्थान, पटियाला से संचालित स्नातकोत्तर डिप्लोमा के समकक्ष है।

लक्ष्मीबाई राष्ट्रीय शारीरिक शिक्षा संस्थान, ग्वालियर एक मुख्य संस्थान है जिसे वर्ष 1957 में एक कालेज के रूप में स्थापित किया गया था और 1995 में इसका स्तर बढ़ाकर इसे समकक्ष विश्वविद्यालय का दर्जा दिया गया।

मंत्रालय के ध्यान में यह बात आई है कि कुछ राज्य सरकारें तथा विश्वविद्यालय कोषों के पदों की नियुक्ति या विज्ञापन जारी करते समय प्रशिक्षण में लक्ष्मीबाई राष्ट्रीय शारीरिक शिक्षा संस्थान, ग्वालियर के स्नातकोत्तर डिप्लोमा को नेताजी सुभाष राष्ट्रीय खेल संस्थान, पटियाला के समकक्ष नहीं मान रहे हैं जिसकी वजह से असमंजस की स्थिति हो गई है।

उपरोक्त स्पष्टीकरण को देखते हुए आपसे अनुरोध है कि सभी संबंधितों को उपरोक्त निर्देश जारी किए जाएं ताकि सभी भविष्य में सभी नियुक्तियों के लिए दोनों संस्थानों के स्नातकोत्तर डिप्लोमा को समकक्ष समझा जाए। जारी किए गए ऐसे निर्देशों की एक प्रति इस मंत्रालय को भी भेजी जाए।
