

The Vice Chancellor of LNIPE, at the outset welcomed all the members present physically and virtually in the General Body Meeting of LNIPE, Society on behalf of President and thereafter requested the Secretary of the General Body (Registrar, LNIPE, Gwalior) to present the agenda items.

Accordingly, Prof. Yatendra Kumar Singh, Secretary of the General Body, firstly with the permission of Chair presented a short video showcasing the Institute and thereafter placed the agenda before of General Body for consideration.

The decisions taken are as under:

**Item-1 CONFIRMATION OF THE MINUTES OF LAST ANNUAL GENERAL MEETING HELD ON 28.09.2021.**

The General Body considered the matter and resolved to confirm the minutes of General Body held virtually on 28.09.2021.

**Item-2 ACTION TAKEN NOTE ON THE MINUTES OF ANNUAL GENERAL MEETING HELD ON 28.09.2021.**

The General Body perused the Action taken and noted the same.



**Item-3****SUBMISSION OF REVIEW PROGRESS & PERFORMANCE OF THE INSTITUTE FROM 2023-2025.**

The Vice Chancellor LNIPE, Gwalior presented a review of the Institute's progress and performance for the year 2023 to 2025. During the presentation, the Vice Chancellor highlighted various academic activities, programmes and other institutional developments (Expansion Plan in Academic & Research, FoP Up-gradation, Conferences & Seminars, School Connect Programme, Vision & Mission, Placement, Scholarship and Unlocking of the LNIPE faculty promotions under CAS as per UGC) through a PowerPoint presentation (**Annexure-1**).

Hon'ble Chair raised the following issues/inputs for consideration:

- To review the student (boys and girls) ratio i.e. 70:30 for UG students.
- To initiate the regular recruitment process to fill up vacant posts.
- To provide assistance to students from economically weaker families to enable them to complete their studies at LNIPE. For this purpose, appropriate rules and regulations may be framed.
- To strengthen and effectively utilize the alumni network of the Institute.
- To identify and train retired sportspersons for upgrading their skills and facilitating their engagement as manpower in sports academies and related institutions.
- Intake of foreign student, especially from BIMSTEC.
- Commercialization of patents granted to LNIPE.

**ITEM-4****(1) CONSIDERATION OF ANNUAL REPORT OF THE LNIPE, SOCIETY FOR THE YEAR 2023-24.****(2) CONSIDERATION OF ANNUAL ACCOUNTS OF THE LNIPE, SOCIETY TOGETHER WITH THE AUDITED REPORT THEREON 2023-24.**

The General Body noted that the *Annual Report* for the year 2023-24 has been approved by the Board of Management and sent to the Ministry for placing before both the houses of Parliament for approval.

The General Body also noted that *Annual Accounts* for the year 2023-24 has already been recommended by the Finance Committee of the Institute and approved by the Board of Management and sent to the Ministry for placing before both the houses of Parliament.

The Secretary also informed that *Annual Report and Annual Accounts* for the year 2024-25 is under process.

**ITEM-5****ANY OTHER MATTER(S) WITH THE PERMISSION OF THE HON'BLE CHAIR.**

After the presentation of the agenda matters of the meeting, the Secretary of the General Body (Registrar, LNIPE, Gwalior) requested all the members to provide their suggestions and inputs. Accordingly, the following suggestions/inputs were given by the worthy members:

- (1) **Ms. Anjali Bhagwat, International Athlete (Shooting)** suggested that a curriculum/programme for Physical Education may be framed wherein foreign language may also be included. Etiquette straining courses for developing HR in Sports and Physical Education.
- (2) **Dr. Vikram Singh**, Prof. and Head, Department of Physical Education, Banaras Hindu University made the following suggestions:

- Research in the field of Physical Education may be strengthened.
  - MoUs may be signed and executed with institutions in the medical and technical fields to strengthen Physical Education and Sports.
  - Short-term capsule courses may also be introduced.
  - Implementation of ITEP as proposed by the NCTE.
- (3) **Dr. Gaurav Singh Kushwah**, Director, School of Physical Education & Sports, Rashtriya Raksha University made the following suggestions:
- LNIPE may establish collaborations with National Sports Federations for organizing training camps (B & C team) at LNIPE, Gwalior.
  - LNIPE may consider expansion through the establishment of additional off-campus or by granting affiliation to suitable institutions.
  - Foreign internship programmes may be introduced for LNIPE students.
  - Greater emphasis may be given to the talent identification of Physical Education teachers and coaches.
  - Annual programmes such as Summer Coaching Camps may be organized regularly.
  - Four year BPES may introduce by LNIPE for sports persons.
- (4) **Dr. Sunita Siwach**, Representative of Secretary, UGC, New Delhi made the following suggestions:
- Skilling of volunteers for International event by LNIPE programme/courses may also introduce to train volunteers.
  - Implementation of the provisions of the National Education Policy (NEP) 2020.
  - Introduction of a one-year postgraduate (PG) programme.
  - Initiation of a Physiotherapy programme at the Institute.
  - Adherence to the prescribed guidelines in relation to foreign programmes.
  - Twinning degree courses to be started at LNIPE.
  - UGC will guide and support.
- (5) **Secretary (Sports), MYAS, Govt. of India** also made the following suggestions/inputs:
- LNIPE, Gwalior should frame refresher courses for Physical Education Teachers for their professional development and betterment.
  - LNIPE, Gwalior to act as a Nodal Agency for planning and organizing the UNESCO World Conclave.
  - The research programme of LNIPE should be reframed and strengthened.
  - LNIPE, Gwalior must ensure that its activities and programmes are aligned with the provisions of the NEP-2020.
  - LNIPE should stand remain as foundation stone in the field of Physical Education.
  - Review and re-plan the RESET programme for retired athletes.
  - Engage alumni network.
- (6) **Smt. Raksha Nikhil Khadse, Hon'ble Minister of State for Youth Affairs & Sports, Govt. of India** also made the following suggestions:
- LNIPE may establish collaborations with State Governments and Private Institutions and plan to run various courses in collaboration of partners.



(7) **Dr. Mansukh Mandaviya, Hon'ble Minister of Youth Affairs & Sport, Govt. of India** also provided his valuable guidance and suggestions:

- The General Body meetings should be conducted regularly.
- A Chintan Baithak to be organized by the LNIPE for bringing Physical Education Teachers and other stakeholders at one place for uniform delivery of courses of Physical Education.
- Council of Physical Education Teacher may be worked out to bring all the Professionals of Physical Education under one umbrella.
- LNIPE, Gwalior to plan and conduct a training module for talent identification of Physical Education Teachers of India, further also emphasized on the research for talent identification.
- To integrate Sports Science experts and coaches for assessing and strengthening the integration of Sports Sciences in sports training.
- To enhance the popularity and visibility of LNIPE, Gwalior.
- Review RESET.
- LNIPE, Gwalior should organize its Alumni Meet on an alternate-year basis.
- LNIPE, Gwalior to develop a self sustained model in future.
