As per the Recommendations of Board of Management in its 59th Meeting dated 27.02.2017 regarding Agenda Item No. **13, 14, 17, 22 (5)** and **(6)** of the 36th Academic Council and Agenda Item No. **5** and **7** of supplementary Agenda of 49th meeting of Finance Committee. The following Rules have been framed with respect to the students of the Institute and its Regional Centre NERC, Guwahati.

RULE - 1 (AGENDA ITEM NO. 13 OF ACADEMIC COUNCIL)**RULES PERTAINING TO ATTENDANCE OF THE STUDENTS.**

The Institute expects 100% attendance from the students in each subject/activity/area of the total curriculum but, due to medical leave/social engagements leave/personal leave, etc., a relaxation of 15% will be given. In exceptional and deserving cases, the Vice-Chancellor may give further relaxation of up to 10% in attendance.

Prior to one month from the date of semester examinations the student must have complete 85% attendance. In exceptional and deserving cases, the Vice-Chancellor may give further relaxation of up to 10% in attendance. Medical Leave and On Duty will only be counted / considered, in cases where the students will have minimum 60% attendance prior to one month before the commencement of Semester Examinations.

All faculty members shall submit the attendance every day to HODs through mail and the copy of the same shall also be sent to Vice-chancellor and after every 15 days the HODs shall submit a hard copy of the student attendance to the Vice-chancellor.

Regarding attendance of Guwahati centre students while On Duty visits to LNIPE, Gwalior. The Students shall get relieving from Guwahati while coming to Gwalior and shall take relieving from Gwalior while returning back to Guwahati.

RULE - 2 (AGENDA ITEM NO. 14 OF ACADEMIC COUNCIL)

THE STUDENTS MUST CLEAR ALL BACKLOGS UP TO SIXTH SEMESTER BEFORE ENTERING IN SEVENTH SEMESTER.

The students of B.P.Ed. must clear all ATKT in sixth semester else they will not be allowed for registration in seventh semester (B.P.Ed. 4-year).

RULE - 3 (AGENDA ITEM NO. 17 OF AC AND SUPPLEMENTARY AGENDA NO. 05 OF FINANCE COMMITTEE)

INSTITUTE Ph.D. SCHOLARSHIP.

The Scholarship to the Ph.D. Scholars will be awarded @ Rs. 8000/- per month along with an Annual Contingency Rs. 15000/- to NET qualified Ph.D. Scholars, who are not getting any other scholarship such as JRF/SRF. The Scholarship will be granted on the basis of their performance in the Entrance Examination of Ph.D. This scholarship will be awarded every year to two (02) Scholars from each department.

RULE - 4 (AGENDA ITEM NO. 22 (5) OF ACADEMIC COUNCIL)

RULES RELATED TO REGISTRATION OF STUDENTS.

The existing rules related to registration i.e. Rs. 50/- per day up to 15 days from the last date of submission of registration form along with requisite fee, shall continue and the span of re-registration with a fee of Rs. 1500/- shall be for 15 days and after a lapse of these 30 days, the re-registration will be made along with a fine of Rs. 3000/- for next 10 days i.e. total 40 days and after lapse of these 40 days no re-registration shall be permitted.

RULE - 5 (AGENDA ITEM NO. 22 (6) OF ACADEMIC COUNCIL)

RULES PERTAINING TO STAY OF STUDENTS.

For all the courses run by the Institute it would be mandatory for all the students to remain in the hostels, as all the courses run by the Institute are 100% residential courses and none of the student will be allowed to attend any course offered by the Institute as day scholar.

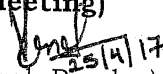


RULE - 6 (SUPPLEMENTARY AGENDA NO. 07 OF FINANCE COMMITTEE)

MERIT SCHOLARSHIP FOR B.P.ED. AND M.P.ED. STUDENTS

1. Merit scholarship of B.P.Ed. and M.P.Ed. will be awarded separately for Gwalior and Guwahati centers from Academic Session 2015-16.
2. Merit Scholarship will be awarded @ 5% of total strength of each course i.e. B.P.Ed. and M.P.Ed.
3. The Merit Scholarship for B.P.Ed. and M.P.Ed. will be awarded annually for students studying in annual system and semester wise for students studying in semester system.
4. The amount of Merit Scholarship will be the total amount of fees and other charges (except caution money) paid by the student to the Institute for the year. In cases where Merit Scholarship will be awarded Semester wise the total amount of fee and other charges (except caution money) paid by the students to the Institute for the particular semester will only be awarded as scholarship.

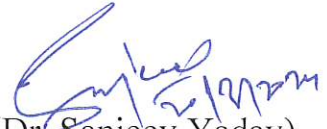

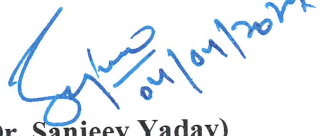
