Sub: Sanction of Grants-in-Aid to Dr. Yajuvendra Singh Rajpoot, Associate Professor, LNIPE, Gwalior for Research Project titled, "Analysis of Kalaripayattu and Thang-Ta skills: In the Perspective of Physiological, Bio-mechanical and Health Benefits" under the Scheme of Human Resources Development in Sports (HRDS)-Release of First installment to National Sports University, Manipur (CNA Agency-NSUSCHEME) and Authorize CNA to set the drawing limit on PFMS Portal, to LNIPE HRDS Gwalior, as per revised procedure for fund flow under Central Sector Scheme-reg.


Sir,

I am directed to convey the approval of the Competent Authority for sanctioning of Grants-in-aid of ₹12,25,000/- (Rupees Twelve Lakh Twenty Five Thousand Only) to Dr. Yajuvendra Singh Rajpoot, Associate Professor, LNIPE, Gwalior for Financial Assistance for Research Project titled, "Analysis of Kalaripayattu and Thang-Ta skills: In the Perspective of Physiological, Bio-mechanical and Health Benefits" under the Scheme of Human Resources Development in Sports (HRDS).

2. It has been decided by the Competent Authority to release a grant ₹3,06,250/- (Rupees Three Lakh Six Thousand Two Hundred Fifty Only) as 1st installment out of total approved amount of ₹12,25,000/- (Rupees Twelve Lakh Twenty Five Thousand Only).

3. I am accordingly directed to convey the sanction of the President of India to release a non-recurring grant of 1st installment of ₹3,06,250/- (Rupees Three Lakh Six Thousand Two Hundred Fifty Only) to National Sports University, Manipur (CNA Agency-NSUSCHEME) and authorize CNA to set the drawing limit on PFMS portal to LNIPE HRDS Gwalior, through NSU (CNA) for Research Project titled "Analysis of Kalaripayattu and Thang-Ta skills: In the Perspective of Physiological, Bio-mechanical and Health Benefits" under Scheme of Human Resource Development in Sports (HRDS).

4. The grants-in-aid sanctioned herein will be drawn by Drawing and Disbursing Officer (Grants-in-aid) Ministry of Youth Affairs & Sports for the purpose on a GIA Bill before 31st March, 2024 for disbursement to the grantee through Cheque/ECS.


5. The release of grant **₹3,06,250/- (Rupees Three Lakh Six Thousand Two Hundred Fifty Only)** to National Sports University, Manipur (CNA Agency-NSUSCHEME) and authorize CNA to set the drawing limit on PFMS portal to **LNIFE HRDS Gwalior** as per revised procedure for fund flow under Central Sector Scheme is further subject to the following terms and conditions:-

- i. The grant should be utilized only for the purposes for which it is sanctioned and the unspent balance of grant, if any, shall be refunded by the grantee immediately after completion of the Seminars.
- ii. The excess amount, if incurred, on the approved Research over and above the grant released shall be borne by the grantee. In other words, no additional grant over and above the approved amount would be provided by this Ministry.
- iii. Assets acquired, wholly or substantially, out of Government grant, except those declared obsolete and unserviceable or condemned in accordance with the procedure laid down in the General Financial Rules (GFRs), shall not be disposed of without obtaining the prior approval of the Department of Sports, Ministry of Youth Affairs & Sports.
- iv. The accounts of the grantee shall be maintained in accordance with the provisions contained in General Financial Rules, 2017 as may be amended from time to time. The accounts of the grantee shall be open to inspection by sanctioning authority and audit, both by Comptroller & Auditor General of India under the provisions of the CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Office of the Ministry of Youth Affairs & Sports, whenever the grantee is called upon to do so.
- v. A report in respect of Research for which grant is being released will be submitted to the Department of Sports, Ministry of Youth Affairs and Sports.
- vi. This is non-recurring grant. The grantee shall be submitted a certificate of utilization of the non-recurring grant for the purpose for which it is being sanctioned in Form GFR 12-A. In addition, an audited statement of expenditure incurred on various components in connection with Research will be submitted to the Department of Sports, Ministry of Youth Affairs & Sports.
- vii. The grantee shall abide by the terms & conditions of the grant.
- viii. The grant is further subject to the conditions laid down in the GFRs, 2017 as may be amended from time to time.
- ix. The grantee should also certify that it has not obtained or applied for grant for the same purpose or activity from any other Ministry or Department of the Government of India or any other Non-Governmental Organization (NGO) or voluntary organization.
- x. The grantee shall ensure that Research is executed in accordance with the provisions of the Scheme of Human Resources Development in Sports (HRDS).

6. It is certified that no UC is outstanding against the Grantee under the HRDS for this financial year.

7. The sanction is being issued in exercise of the powers delegated and in conformity with the rules and principles as approved by the Ministry of Finance. It is also certified that the pattern of assistance has the approval of the competent authority.

8. The Ministry of Youth Affairs & Sports will authorize to **National Sports University, Manipur (CNA Agency-NSUSCHEME)** to set the drawing limit on PFMS portal for further authorization of funds to **LNIFE HRDS Gwalior**, in its HDFC Bank Account No.50100584115729, IFSC- HDFC0005051. Accordingly, the amount of **₹3,06,250/- (Rupees Three Lakh Six Thousand Two Hundred Fifty Only)** shall be electronically transferred to **LNIFE HRDS Gwalior**, HDFC Bank Account Number 50100677481060, IFSC Code: HDFC0000192, City Centre, Gwalior, MP.
