


**TENDER DOCUMENT FOR**  
**ANNUAL COMPREHENSIVE MAINTENANCE CONTRACT OF 3 Nos. LIFT (KONE) AT**  
**L.N.I.P.E., GWALIOR**

**(A) ELIGIBILITY CRITERIA:**

The bidding agencies are required to submit the technical bid in the format given at **Annexure 'A'**, along with copies of following documents, duly signed/self-attested, with the technical bid for being declared to be eligible:-

1. Name of the bidder with complete address, Phone Number, e-mail, website etc.
2. Status of the bidder i.e. Public Limited/Private Limited/Partnership firm or Proprietorship firm (Certificate of incorporation to be enclosed).
3. CGST/SGST Act (Registration along with latest GST Return to be enclosed);
4. Income Tax Act (copy of PAN Card to be enclosed);
5. Average Annual financial turnover during the last 3 financial years, ending 31<sup>st</sup> March 2025, should be at least 30% of the estimated cost ("Certificate of Turnover" issued by a Chartered Accountant in the format prescribed in the tender document at **Annexure 'B'**, to be submitted along with balance sheets of relevant years' with Income Tax Returns).
6. Experience of having successfully completed similar works i.e. "**Comprehensive Annual Maintenance Contract of Lifts**" during last 7 years (up to November 2025) in Government or Private Organizations/PSUs/Educational Institutions, as under:-

Three similar completed works each costing not less than the amount equal to 40% of the estimated cost;

OR

Two similar completed works each costing not less than the amount equal to 50% of the estimated cost;

OR

One similar completed work costing not less than the amount equal to 80% of the estimated cost.

(Copies of work orders as above with their respective contract completion certificates to be enclosed).

7. A declaration to the following effect is required to be submitted on affidavit on non-judicial stamp of Rs. 100/- that
  - a) There is no pending case before any Court of law against the Proprietor / firm / Partner or the bidder company;
  - b) The bidder has not defaulted from the payment of statutory dues like EPF, EST, GST, Income Tax etc. during the last three years;
  - c) The bidder is not blacklisted by any Government Organization/PSU/Autonomous Body/Govt. Educational Institute during last three years, nor has any of its contracts have been terminated before expiry of term during the last three years.




**(B) FINANCIAL BID:**

1. Financial bid is required to be submitted in the format at **Annexure 'C'**.
2. The rates quoted should be inclusive of all taxes. Nothing additional shall be payable during the period of agreement.

**(C) SCOPE OF WORK:**

1. Monthly preventive service and breakdown maintenance of Lifts to keep them functional through-out the maintenance contract period.
2. Service the lift/s at regular intervals and as frequently as the company deems necessary based on the age, nature, type, location and condition of the elevator and we will take all reasonable care and maintain the lift equipment in safe and proper working condition.
3. Replenish the Gear and Motor bearing with necessary Johnson lubricants whenever necessary and all parts of the lift will be checked, cleaned and lubricated to keep them, both mechanically and electrically in perfect working condition.
4. At the expiry of contract period, the contractor shall hand over the Lifts in working condition.
5. The contractor shall ensure that all the complaints are attended to and rectified within one working day. If the contractor fails to attend the complaint within one day, a penalty @ Rs. 500/- per working day per lift will be imposed and will be recovered from the next bill of contractor.
6. In the event of failure of contractor to remove the complaint within one week, the Institute would be at liberty to get it attended by outside vendor/firm on payment basis, cost of which shall entirely be deducted from the contractor's succeeding bill.
7. All the repairs, replacement and maintenance, preventive check-up/cleaning shall be made by the contractor with due intimation to the incharge of said building/department and written report(s) of completing work will be got signed from them, which will be submitted along with quarterly bill(s).
8. The Institute will not pay any extra amount towards labour wages, ESI, EPF, uniform, badges etc.
9. The bidders are advised to visit the Institute and inspect the Lifts to be covered under the AMC through this tender process.





**(D) DETAILS OF LIFTS PRESENTLY INSTALLED IN THE CAMPUS :**

The particulars of LIFTS with locations installed in the LNIPE Campus are given as under:-



**(E) PROCEDURE OF TENDER SUBMISSION :**

- (1) Tenders are required to be submitted in a main sealed envelope super scribed as “**Annual Comprehensive Maintenance Contract of 3No.s lifts (KONE) at L.N.I.P.E., Gwalior**” and it has to be dropped in the tender box kept in the office of Deputy Registrar (Estate) by **03:00 PM** on 19.12.2025. The same can also be sent by speed post / registered post by clearly mentioning the above subject on the envelope, and in such cases, it would be responsibility of the bidder that the same is reached to the Institute by **03:00 PM** on 19.12.2025.
- (2) The main tender envelope should contain duly filled in “**Technical Bid**” as per “**Annexure’s**” along with required documents and **Annexure ‘B’** as prescribed hereinabove & Containing “**Financial Bid**” in duly filled in “**Annexure ‘C’**”
- (3) All pages of technical bid and financial bid shall be duly page-numbered and signed by the bidder at bottom
- (4) Photo copies of all the documents shall be self-attested.
- (5) Conditional bids will not be accepted.
- (6) At any time prior to the opening of bids, the Institute may, for any reason, modify the tender document by suitable amendments/corrigendum through website of Institute. No separate communication shall be required to be sent to the prospective bidders.
- (7) The bidders will comply with the conditions mentioned in the tender document and accordingly clearly fill all the columns in both the formats (technical and financial), failing which, the Institute reserves the right to reject the same.
- (8) Incomplete filled-in tenders shall be summarily rejected.
- (9) The bids shall be opened as scheduled in the Notice Inviting Tender, in the presence of bidders or their authorized representatives, if any.
- (10) In case there is public holiday on the scheduled date of opening of technical/ financial bids, the same shall be opened on the next working day at the same time.
- (11) The bidders are expected to see the site to inspect repair work in question, which is required to be declared in the tender form.
- (12) No correspondence shall be made with these bidders, whose bids are rejected on the basis of technical or financial.

**(F) GENERAL CONDITIONS OF CONTRACT :**


- 1. The contract shall be awarded for a period of 12 months from the date of agreement, which may however be renewed for a further period of two years, on annual basis at a stretch, subject to satisfactory performance of the contractor, as also, mutual consent of the Institute and contractor, at the contract rate enhanceable by a maximum of 5% over and above the prevailing contract value.


2. The Institute reserves the right to terminate the contract forthwith at any time during the period of contract, without assigning any reason or in the case of poor performance of the contractor.
3. This Notice inviting tender shall form part of the contract document having binding effect on the successful bidder.
4. After communication regarding award of work, the successful bidder shall, within 15 days, submit a non-judicial stamp of Rs. 100/- and execute an agreement with the Institute for the work, on the terms & conditions of the present tender.
5. The successful bidder contractor shall also be required to furnish performance guarantee @ 10% of the contract value in the form of Bank Draft or Fixed Deposit in the name of Registrar, LNIPE, Gwalior. The said performance guarantee shall be refundable on successful/satisfactory completion of contract period or extended period, if any, on written request by the contractor in this regard. No interest shall be payable on such refund.
6. The bidder shall quote their rates as per various terms and conditions given in the tender document. All the required material and labour will be provided by the contractor.
7. The competent authority of Institute reserves right to accept the whole or any part of the tender and the contractor shall be bound to perform the same at the quoted rates.
8. The payment shall be made to the contractor on quarterly basis on receipt of bills in duplicate along with satisfactory work reports from the incharge of said building/department duly signed by the end users, with all the required documents like periodic monthly preventive check-up of Lifts etc.
9. Sub-contracting shall not be allowed.
10. If the contractor withdraws during the period of contract or fails to perform the work as per contract up to the satisfaction of the Institute, or commits breach of any of the terms and conditions of contract, then the Institute shall have right to forfeit performance guarantee, as the case may be, and/or terminate the contract by giving 1 (one) month written notice in this regard, to the contractor. The Institute shall also have the right to blacklist the contractor.
11. The contractor will not be entitled for any compensation due to enactment of any law / regulation etc. during the currency of the contract. All Taxes on materials or any element of this contract shall be payable by the contractor and the Institute will not entertain any such claim whatsoever in this respect. The contractor's rates shall cater to all such taxes.
12. The Institute will deduct income tax and any other tax applicable, at source from all the payments made to the contractor under this contract, in accordance with the provisions of IT Act or any other law as applicable from time to time.
13. The quoted rates shall be inclusive of GST, if any and the contractor will not be entitled for any compensation due to enactment of any law / regulation etc. during the currency of the contract. The Institute will not entertain any such claim whatsoever in this respect.
14. The criteria for tender award will be mainly based on the lowest quoted rates by the eligible bidder.

15. The Institute reserves the right to ask justification(s) of quoted rates before finalization of contract.
16. The contractor will be responsible to bring to immediate notice of the Electrical Engineer any abnormal functioning or faulty operation of any equipment and take timely steps to avoid breakdown/disruption.
17. The contractor shall be responsible for any damage to the equipment, machinery or system on account of negligence/fault of the contractor's authorized staff and the same will have to be made good at his risk and cost.
18. In the event of any dispute between the Institute and contractor, the Arbitrator shall be appointed by the Vice Chancellor, LNIPE, Gwalior and the matter shall be referred to so appointed Arbitrator, whose decision shall be binding and final.
19. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the bidders, who resort to canvassing will be liable to rejection.
20. Any dispute arising out of the contract between the Institute and contractor, shall be subject to the territorial jurisdiction of Gwalior.






