
(i) Further, the faculty member mentioned at serial number 7 of Table-3, was one of the respondents in Civil Appeal filed by the Institute before Hon'ble Supreme Court bearing CA No. 5744/2009, but was not impleaded as a party in MP No. 677/2025 order dated 29.10.2025.

The Board was apprised about the legal opinion of ASG, M.P., the case of faculty member mentioned at serial number 7, Dr. Rajkumar Sharma in Table-3 should be treated in accordance with, and in light of, the recommendations made in respect of the six employees mentioned from serial number 1 to 6 of Table - 3.

The case of Dr. Raj Kumar Sharma stands on the same footing as that of the aforementioned six employees. He was a petitioner before the Hon'ble High Court in WP No. 3887 of 2005 and an appellant in WA No. 390 of 2006 he was also arrayed as a respondent in the Civil Appeal filed by the Institute before the Hon'ble Supreme Court bearing CA No. 5744 of 2009.

The Board also considered and decided the case of Dr. Raj Kumar Sharma strictly in accordance with, and in light of, the recommendations made above in respect of the aforementioned six employees.

The Board perused the matter and resolved to authorize the Vice Chancellor to constitute a committee to examine the case of Dr. Raj Kumar Sharma who was also reinstated along with the six employees as mentioned in serial number 7 in Table-3.





Reference: Office Order No. BOM/68/2024/1465-1480 dated 04.09.2025

Respected Madam,

With reference to the subject and the office order cited above, I would like to formally submit my **Note of Dissent** in regard to **Item Nos. 7, 9 to 12** of the Minutes of the Board of Management (BoM) Meeting held on 26.08.2025.

In the said Minutes of Meeting, it has been recorded:

"The Board discussed the matter at length and noted that the issue is sub judice, currently pending before the High Court and the Central Administrative Tribunal (CAT). Accordingly, the Board resolved that the legal opinion from a senior Government Legal Counsel be obtained prior to finalizing any decision on the matter."

However, I strongly object to this recording and wish to submit the following points as grounds for my dissent:

Grounds for Dissent:

1. **Incorrect Record of Proceedings:**
It is incorrectly recorded that the Board decided to obtain legal opinion from a Senior Government Legal Counsel. No such discussion or resolution was made during the meeting for the said items.
2. **Deviation from Actual Decision:**
The Board had, in fact, agreed to constitute a High-Level Independent Committee to examine and implement all representations, complaints, relevant court judgments, and interim orders—including matters under ongoing litigation.
3. **Contradiction of Board's Resolution:**
The decision to seek external legal opinion represents a clear deviation from what was actually discussed and resolved in the meeting.
4. **Violation of Court Orders:**
Where there are clear directions/interim orders from Hon'ble Courts, the same are required to be implemented in *toto* without delay. Seeking further legal opinion on such matters may amount to contempt of court.
5. **Contempt of Court in Item 7 (f):**
Specifically, in Item No. 7, sub-point (f), it is stated that a Senior Legal Counsel is

requested to suggest which envelopes are to be opened. This is in direct violation of respective court orders and also contravenes CCS Rules, 1964.

6. Non-reporting of Critical Cases:

As a Board Member, I have received multiple representations concerning pending litigation and criminal trials involving the following employees:

- o Megha Shau – WP 2161/2021
- o Amit Yadav – WP 2161/2021
- o Indu Bora – WP 2161/2021
- o Payel Das – RCT 1320/2023, FIR 0508/2022

It is surprising and concerning that these significant cases were not reported or included in any agenda items, while other cases were selectively added and discussed. These cases have been pending since 2021 and merit equal attention.

7. Selective and Biased Reporting:

The selective inclusion of legal matters for discussion and decision-making raises questions on the transparency and integrity of the Board's functioning. It appears arbitrary and biased, undermining the principles of natural justice.

My Submissions:

In light of the above, I reiterate my dissent on Item Nos. 7, 9 to 12 of the Minutes of the BoM meeting dated 26.08.2025.


I further submit that the decision, as correctly discussed in the meeting, should be to constitute a High-Level Independent Committee as per the CCS Rules, 1964 to:

- Review all pending representations and litigations,
- Implement judicial directions *in toto*.





The Board further decided that the matter relating to the movement of **Dr. Payel Das from Stage-1 to Stage-2 shall be initiated afresh.**








